A Message from the Executive Director



It has been an amazing year of energy and growth at WCAC! We are on track to achieve our goals within five strategic areas—Education, Employment, Energy, Asset Development, and organizational Capacity Building—to help people move to self-sufficiency. These strategies ultimately support the economic agenda in the region and the state.

It took an energetic staff, team and board leadership to deliver 20 high-demand programs to more than 72,000 people in 37 communities! Thank you all. I am pleased to report that our budget doubled since 2006 from \$13 million to over \$25 million this year. Our energy programs are expanding; following three record-breaking years, we expect more than 16,000 households to apply for fuel assistance an indication that the economy continues to bear down heavily on the ability to pay for everyday bills such as food and fuel.

WCAC supports the national agenda through the American Reinvestment and Recovery Act (ARRA). The agency received over \$11.3M in federal stimulus funds for education, jobs, energy, and asset development programs. Combined with state resources, WCAC administered a \$1.4M ARRA summer jobs program for nearly 1,000 youth in this region. Our Job and Education Center opened in October to help 100 young adults with preemployment, educational advancements,

and job placements. The weatherization program is receiving \$8.3M over a threeyear period to enhance energy efficiency in homes in this region, and \$465,000 in Head Start ARRA funds for program expansion, staff development, and wages.

Over 20 partnerships are energized and growing! WCAC was invited to join two important energy collaboratives this year: the State Energy Sector Partnership comprised of the Department of Higher Education and Labor and Workforce Development to collaborate with regional leaders and support regional education and training, along with the Institute for Energy and Sustainability—a group focused on developing Central Massachusetts as a green energy sector.

We look forward to welcoming District Attorney Joseph Early, Jr., along with Dale Allen, Vice President Community Engagement/QCC who will serve as the designee for Senator Michael Moore-both in public sector seats; Steven Joseph, UNUM Senior Vice President, Individual Disability Business Operations, to represent the private sector; and Michele Mann for Head Start Policy Council in the year ahead.

In 2010, we will celebrate WCAC's 45th anniversary, observe the agency's great work over time and honor our dedicated staff, volunteers, and partners. Our program will include a tribute to one of our long-time heroes, Senator Edward M. Kennedy, a man who supported community action work and stood ever-ready to speak on behalf of those who had little

means, were less fortunate or downtrodden. During this gala event on April 28, 2010 at Mechanics Hall, we will look intently toward our future. It is bright, filled with promise, possibilities, and pathways to self-sufficiency, and all of this, we know, will be fueled with great energy. I hope you will join us!

A WCAC staff member for 10 years, Mayra Nieves is described by co-workers and volunteers as "caring, dedicated, empathetic, and strong." Mayra is the Agency's expert on nutrition assistance, an intake specialist for the Earned Income Tax Credit (EITC) program, and a highly-respected Parent Advocate in the Worcester Community Connections Coalition (WCCC) Program. Mayra has helped hundreds of low-income, at-risk, and under-served families in Worcester access hard-to-reach community resources.

Mayra is the sole worker for the Supplemental Nutrition Assistance Program—SNAP (formerly Food Stamps)—at WCAC. In 2009, she served over 421 families. She was recently promoted to working full-time for WCAC in that capacity. Mayra was noted as being one of the most knowledgeable and skilled food stamp workers in the state by Project Bread in Boston--a former funding source for WCAC's SNAP program. Anne Bureau, Director of WCCC said, "Despite many changes in program demands over the years, she has always maintained her positive attitude, calmness, adaptability, and excellent client-service skills." Mayra began her involvement with WCAC as a volunteer and before settling into her current role, Mayra held various advocacy positions. The ability to come to work everyday and help clients through a crisis or with daily needs continues to motivate Mayra. "I make sure clients get everything they need when they are here. I provide them with resources for housing, advocacy, shelters, food pantries, and food stamps. I am very happy to be here," she said.

Mayra conducted extensive community outreach efforts, as well as participated on several committees to improve the lives of Worcester residents. When Lakeside Housing Development residents needed a stronger voice and greater access to community resources, she assisted in the organization of the Lakeside Interagency Task Force. Mayra also coordinated a program called "Paint the Future" in collaboration with Worcester Shines to beautify the Lakeside area by painting murals over graffiti. She is extremely proud that, to this day, there has not been any graffiti over their efforts. She was also a member of the founding committee for the WCCC Parent Center that opened in February 2008.

Staff, Coalition Members, and Agency customers sincerely enjoy working with Mayra who always places clients' needs as her number one priority. One Parent Center Volunteer describes Mayra as, "...sensitive to the needs of families. She makes you feel comfortable—not bad for trying to get services. She even takes the extra step to help you get the other services you need besides food stamps." Mayra is truly one of WCAC's shining stars!



Partnerships, Outreach, and Advocacy

While many of our programs and services have definitive outcomes, WCAC staff and the Board of Directors, as marketing "ambassadors," are members of numerous boards, committees, and working groups at the state, regional, and local levels. These partnerships include the City of Worcester, Worcester Public Schools, the Rennie Center, Central MA Regional Employment Board, Workforce Central Career Center, Regional Chambers of Commerce, non-profit affiliate organizations, MASSCAP, United Way of Central Massachusetts, Center of Hope, FDIC's (Federal Deposit Insurance Corporation) Economic Inclusion Council, local finan-

cial institutions and credit unions along with the State Energy Sector Partnership, Worcester Business Development Council, Worcester Public Library, Older Women's League, Female Leadership Interest Council, Early Education and Care, Worcester Lead Action Collaborative, Massachusetts Directors' Energy Association, Blackstone Valley Education Foundation, Youth Advisory Committee, and numerous hunger and homeless collaboratives. These participatory memberships allow WCAC staff to educate and further inform over 4,000 individuals and groups about WCAC's mission, programs, legislative issues, and client needs.

Priscilla Holmes is the essence of Worcester Community Action Council and truly exudes through her words, deeds, and actions, the mission of Community Action Agencies nationwide. Priscilla recently celebrated a 20-year tenure at Worcester Community Action Council with a rich track record that extends well before her service at WCAC and includes extensive work in workforce development, education, and life-skills training for scores of low income residents. Her belief in equal rights, social justice, and respect for all permeates every assignment and role she takes on. Her duties as Deputy Director include assisting the Executive Director in administering the \$25 million WCAC antipoverty agency for Central Massachusetts and South County. In her work at WCAC, Priscilla is known as a consummate professional who consistently demonstrates her keen leadership, decision-making and team building skills--most recently as Director of Programs. She inspires and challenges her staff who describe her as "intelligent, articulate, open-minded, and a really terrific boss."

She is a strong, steady, reliable partner who provides sound advice and is a great "team player." She understands how seemingly small decisions and details from service delivery and programs fit into the larger picture of systems change, policy development and long-term community impact.

Priscilla is a diplomat and readily gives credit to staff and volunteers for their work and successes. She is also ever-humble, but proudly notes her best work: "I am most proud of my two daughters who work hard to make the world a better place...and two beautiful granddaughters, Molly and Payton, who make my world a terrific place."

Success Story Winnie Octave



"WCAC saved my life and my children's lives. WCAC prevents people from falling on their faces....it gives them strength to walk again," exclaims Winnie Octave, board member and Worcester Community Connections Coalition (WCCC) Parent Center volunteer. Over a 10-year period, Winnie has traveled a winding path from being unemployed to entering a Bioengineering Life Sciences program at Worcester Polytechnic Institute this fall through President Obama's College Scholarship Program For the Single Working Mom.

After moving to Worcester from New Jersey with her three children in 1995, Winnie secured a job with Ellis & Ellis. When the business closed in 1999, she was referred to

WCAC by Workforce Central Career Center. Here she received pre-employment training to include Microsoft Office computer skills, mock interviewing, how to dress professionally, how to work as a team player, and she met with business representatives who interviewed candidates upon successful completion of the program. In 2000, Winnie was hired full time by Chapter 13 Trustee—a private company providing bankruptcy services--and at the same time, she was invited to join the WCAC Board of Directors.

Winnie learned about the First-Time Homeownership Program from WCAC staff, and she purchased a spacious home through the East Side Community Development Corporation. Winnie beams when she recounts all of her awards: in 2003, she was congratulated by Congressman Jim McGovern on receiving the WCAC Warm Friends Award. Later that year, as a committed WCAC board member, she was invited by Senator Edward M. Kennedy to testify before the Senate Subcommittee Hearing in Washington, D.C. on the importance of continued federal Community Services Block Grant (CSBG) funding to community action agencies. CSBG supports children and families. Winnie had the distinct pleasure of meeting with the Senator oneon-one: "We sat on a bench in the hallway; just me and the Senator talking about children....he was real!" During her visit in Washington, she met Hillary Clinton and supported her efforts to increase wages. Winnie was honored with the MASSCAP Self-Sufficiency Award for working in the community, taking care of children, having a full-time job, and purchasing a firsttime home.

Nine years ago, Winnie, along with many parent volunteers, advocated for a dropin center within WCAC's WCCC that would provide referrals and support to local parents and families. In 2008, the WCCC Parent Center was established at WCAC and, since its inception, has served hundreds of parents and families and continues to be an invaluable community resource.

"WCAC is the husband I don't have, and all the support I have been given is like little gifts," she says. "I'm happy to do whatever I can...I believe that I must always give back. It's the best way to enjoy life. WCAC gave so much....and still gives so much to me." Winnie will talk to anyone or any group about the help she has received from WCAC. She was asked to serve as the keynote speaker for WCAC's first GED graduation in June, sponsored by UNUM, which was held at Tuckerman Hall. She addressed a large audience of students and families about the importance of education and perseverance.

Winnie is a single mother of three children: her oldest son is 28 and has served 10 years in the Marines, her 20-year-old daughter is enrolled in the UMass Amherst nursing program, and this past summer, her 14-year-old son got his first paid job through WCAC's state-funded Youth-Works program—a seven-week employment initiative for eligible 14-21 year-old young people in Worcester. He saved his money for Kimball Union Academy in New Hampshire, where he was accepted with a full scholarship this past fall.

Winnie's parting words for everyone— "Broaden your territory! Get to know people, ask questions, and life becomes much better! React to life and life will react to you!"

Youth Employment Partners

WCAC was fortunate to have received \$1.4M in federal Workforce Investment Act (WIA) Summer Youth Employment Services stimulus funding to serve over 500 income-limited young people ages 16-24 in Worcester and the surrounding communities, as well as the Blackstone Valley and South County Corridors. At the same time, WCAC was awarded the state YouthWorks Summer Jobs Program grant to serve over 400 youth ages 14-21 in Worcester. Almost 1,000 young people were placed in summer jobs this past summer!

We are thankful to over 158 employers who provided meaningful employment to these young people over a seven-week period.


